## NOTICE OF APPLICATION OF HERBICIDE

Date: April 15, 2021

This notice is to inform you of the dates that we plan on treating the school grounds for weeds. At East, Central and the A-Field we plan to treat the grounds with a weed and feed product much like you use at home. At East, we will treat areas along Seventh Street around to Farrell Road. We will also treat the property from Farrell Road and around the back of the school inside the creek to the tennis courts. The varsity soccer field will not be treated at East at this time. We will spot spray this field when necessary. The grass outside the fence at the A-Field will also be treated at this time.

The small lawn around Central Campus will also be treated. The herbicide application for this spring is scheduled to take place on Sunday, April 25, 2021. If it rains on April 25<sup>th</sup>, we will treat the grounds on Sunday, May 2, 2021. If you would like a copy of the SDS for the products we plan to use, please contact the Business office at (815) 588-8113.

The greens on the golf course are usually sprayed with a fungicide every other week from May 10<sup>th</sup> to September 17<sup>th</sup>. If needed, they are sprayed every other Thursday afternoon at 2:00 pm, weather permitting. A small sign will be posted on each green when the greens are sprayed.

Only if needed, spot spraying for weeds will occur on certain athletic fields when school is out. Signs will be posted when the fields are sprayed.
